

Senior Residential Options

Levels of care for those with Dementia

In Home Care

In home care to ensure safety and quality of life. Caregivers come into the home to help with personal care, medical help and with daily home needs.

Adult Day Centers

These facilities allow the senior to remain living at home but gives the family a safe place for the senior to go during the daytime to have activities, medical supervision, meals & socialize with others.

Senior Shared Living

Homes designed to bring seniors together as housemates but live independently and remain active in their communities.

Assisted Living

Housing for elderly or people with disabilities that provides nursing care, housekeeping and prepared meals as needed.

Memory Care

A distinct form of long-term care designed to meet the specific needs of a person with dementia or other cognitive difficulties.

Skilled Nursing

An in-patient rehabilitation center staffed with trained medical professionals.

Nursing Home

A community designed for individuals with higher medical needs. Nursing homes provide 24-hour medical care.

Naperville Police Department

Caring Hands Program

A person with dementia or other disorders can have pertinent information added to the emergency -1st responders database.

Fast Track Program

A radio technology used in lifefsaving program to help locate missing persons with disabilities.
