In addition to the work of the Boards and Commissions, a number of additional efforts were completed:

- Appointed twenty-four students to serve on twelve different boards and commissions
- Implemented background checks as part of the application process
- Held two training sessions for board and commission chairs
- Standardized public participation, opening comments and meeting procedures across boards
- Created a board and commission attendance tracking dashboard
- Created a resource site for board and commission liaisons

- June- Approval of City Council liaison appointments to various boards and commissions.

Staff will also be working with Board and Commission members to provide training on meeting procedures, roles and responsibilities and refresher training on Open Meetings Act and Freedom of Information Act. Additionally, staff will be working with board and commissions to audio record meetings which will then be uploaded to the City government meetings webpage.

Advisory Commission on Disabilities 2024 Annual Report

2024 Accomplishments

- Onboarded a new Commission Chair, two Commissioners, and a staff liaison.
- The Commission had quorum for meetings this year, no meetings needed to be cancelled.
- Several presentations were made this year on topics and issues of importance to the Commission: Right-of-Way Transition Plan from T.E.D., Diversity, Equity and Inclusion (DEI), Special Events, and the Fire Department's C.A.R.T. program.
- Discussed and presented recommendations on ADA concerns with one of the City's special events.
- Members of the Commission were involved in housing projects and new developments in the City, i.e. Tower Court on 103rd and Rt. 59 and the West Street Executive Homes.
- Organized the Special Olympics Day in the City of Naperville which included a Proclamation from the Mayor.
- The ACTF made presentations at each meeting on their projects and programs, which included: updating the ADA icon, NCC accessibility survey of the Riverwalk and addressing Visitability with developers and staff.

2024 Challenges

- The scope of the Commission is limited and would like to broaden the scope to include additional public buildings outside of the Municipal Center and additional issues of concern.
- Educating project managers on accessibility issues to make sure this topic is always included in new and existing projects throughout the City.

2025 Upcoming Work

- Host an All-Abilities Fair in July
- Work with the Fire Department on promoting and marketing the C.A.R.T. program.
- Continue to have presenters at Commission meetings on various topics of importance to the Commission.
- Partner with the ACTF on recognizing friendly and accessible businesses and organizations in the City.
- Educating project managers on accessibility issues to make sure this topic is always included in new and existing projects throughout the City.

Board of Fire and Police Commissioners

Board Details

The Board of Fire and Police Commissioners (BOFPC) is responsible for selecting and appointing qualified candidates for the positions of Police Officer and Firefighter/Paramedic. The board is also responsible for the promotional process for the Fire Lieutenants and Captains and Police Sergeants, including the testing and selection processes. The BOFPC conducts disciplinary hearings or appeals of disciplinary action in the Fire and Police Departments. The BOFPC is established through Illinois State Statutes, the Illinois Municipal Code and the Naperville Municipal Code.

Board of Fire and Police Commissioners 2024 Annual Report

2024 Accomplishments

At the beginning of 2024, the BOFP set quarterly interview dates for new hire Police Officer oral interviews, to give candidates an expected timeline of events and as a way to speed up the hiring process. During 2024, the BOFP held 2 lateral Police Officer interview processes, 2 new hire Police Officer exams, and 2 Firefighter/Paramedic exams which resulted in hiring 14 lateral Police Officers, 4 original appointment Police Officers and 8 Firefighter/Paramedics. The BOFP held special meetings when needed to help speed up the process of getting candidates hired.

2024 Challenges

One of the challenges the BOFP experienced in 2024 was a lower turn-out in applicants taking the new hire exams, leading to holding a second exam for both fire and police. The BOFP also experienced a slight increase in candidate appeals, as well as a slight increase in candidate withdrawals from the hiring process.

2025 Upcoming Work

In 2025, the BOFP will continue to set quarterly interview dates for Police Officer oral interviews. The BOFP plans to run two new hire exams for both fire and police. The BOFP will also review and make necessary updates to the Rules and Regulations. There will also be a Police Sergeant testing process in 2025 in which the Board will be a part of oral interviews and reviewing any challenges that come from the written exam.

Emergency Telephone System Board

Board Details

The Emergency Telephone Systems Board (ETSB) coordinates the implementation, upgrade and maintenance of the emergency telephone system. The board manages the Emergency Telephone System Fund which includes deposits from the E911 surcharge and disbursements for projects associated with the emergency telephone system. The board is comprised of Police, Fire and elected officials from Naperville, Aurora, and North Aurora in addition to two Naperville residents and one Aurora resident.

Emergency Telephone Systems Board 2024 Annual Report

2024 Accomplishments

The Emergency Telephone Systems Board (ETSB) is comprised of Police, Fire and elected officials from Naperville, Aurora, and North Aurora in addition to two Naperville residents and one Aurora resident. In 2024, the ETSB met quarterly to manage the Emergency Telephone System Fund and coordinate the implementation, upgrade and maintenance of the emergency telephone system. In accordance with 50 ILCS 750, the ETSB reviewed and accepted the receipt of \$5,541,365.57 in E911 surcharge funds from the State of Illinois to reimburse allowable expenditures. \$3,058,871.20 was approved for transfer to the City of Naperville General Fund and \$2,482,494.37 was approved for transfer to the City of Aurora.

2024 Challenges

2025 Upcoming Work

The ETSB will continue to meet quarterly to review revenues received and approve reimbursements for allowable expenditures associated with the emergency telephone system. The board will ensure funds are allocated transparently in compliance with the ETSB Act to advance the public safety communications for the cities of Naperville, Aurora and North Aurora. In 2022 and 2023, the ETSB reviewed and accepted the receipt of \$1,865,367.41 in E911 special distributions from the State of Illinois. These funds remain in the Emergency Telephone System Fund to reimburse portions of future capital project expenditures for both Naperville and Aurora.

Financial Advisory Board

Board Details

The Financial Advisory Board is responsible for reviewing and providing recommendations on fiscal policies, financial reports and budgets to the City Council. The Board also assists the City Manager and Finance Director on special projects that affect the financial affairs of the City.

Financial Advisory Board 2024 Annual Report

2024 Accomplishments

- **Investment Portfolio Monitoring:** The Board participated in monitoring the investment portfolio through quarterly reports prepared by the City's Investment Advisor, Marquette Associates, and an annual review with each investment management firm in April.
- Investment Benchmark Review & Investment Policy Update: The Board reviewed the performance benchmarks by which the investment managers are measured. As part of this review, the Board recommended minor changes. The Board's recommendations were reflected in a revision to the *Investment and Cash* Management Policy, which was approved by the City Council in May.
- Utility Rate Review: In 2024, the City conducted rate studies for the Electric and Water Utilities to set rates for 2025 through 2027. In August, the consultant recommendations were presented to the Financial Advisory Board. The Board reviewed the rate recommendations, including proposed debt issuances for capital improvements. The Board challenged staff to consider lower water rates through the issuance of more debt for long-term capital improvements. Staff modeled additional scenarios based on that direction and reduced the initial 23% rate increase to 12%. In October, the Board recommended the revised rates, which were ultimately approved by the City Council in November.
- Quarterly Budget Review: The Board received quarterly budget reports at each
 of its regular meetings. In October, the Board received a summary of the proposed
 2025 Annual Budget.

2024 Challenges

 Board Vacancies: One seat remained vacant throughout the second half of 2024; however, the Board had generally good attendance throughout the year and was able to meet a quorum for all scheduled meetings.

2025 Upcoming Work

- Review the General Fund Emergency Reserve (Fund Balance) Policy and recommend updates as needed.
- Review revenue replacement options to address statewide Grocery Tax elimination in 2026.

Historic Preservation Commission

Board Details

The Historic Preservation Commission reviews and makes recommendations on applications for new and expanded Historic Districts and landmarks. The commission also grants or denies applications for Certificates of Appropriateness, guides the development of Historic Building Design Guidelines, and assists in educating residents about available resources for preservation activities. Four members of the commission are owners or residents of the Historic District or a landmarked property.

Historic Preservation Commission 2024 Annual Report

2024 Accomplishments

- The Commission conducted 5 public hearings (4 COA requests, 1 Landmark)
- Voted to approve 4 of 5 public hearings
- Received 1 report regarding new business. Contents of the report include:
 - Requiring certain qualifications for contractors undertaking large room additions or major renovations in the historic district.
 - Requiring three-dimensional model drawings for large room additions or major renovations in the historic district.
- Undertaking a survey of the historic district to proactively identify distressed, neglected or vacant properties.
- The HPC also shared their interest in commissioner training, historic preservation workshops, and encouraging more discussion between the Commissioners at meetings.
- Recommended approval of one local landmark (the 5th in Naperville)
- Reviewed and commented on the 2024-2034 North Central College Master Land Use Plan as it pertains to historic preservation
- Elected a Vice-Chairman and Secretary
- Robert Sanchez was appointed to the Commission in March

The Human Rights and Fair Housing Commission plays an important role in the development and implementation of City policies related to housing, unlawful discrimination and fair housing. The commission educates and engages the community in efforts to promote increased awareness and understanding, eliminate discrimination, and act as a point of contact for issues related to housing, unlawful discrimination and unfair housing practices. The commission is also responsible for receiving and investigating complaints and alleged violations of the City's human rights and fair housing regulations. Members shall have experience in the various aspects of the duties of the Commission by virtue of their training, life experience or employment. The Commission shall be broadly representative of the City's population and shall include members of Naperville's minority communities.

Human Rights and Fair Housing Commission 2024 Annual Report

2024 Accomplishments

In 2024, the Human Rights and Fair Housing Commission received and reviewed complaints of discrimination alleging violations of Title 12 of the Naperville Municipal Code. After investigations were completed pursuant to the Commission's direction, final determinations were rendered. The Commission also received an update on the status of the Impediments to Fair Housing Study. Some members of the Commission attended various events co-hosted by the City in partnership with entities such as the Public Library to support the city's mission of "creating an inclusive community that values diversity." The Commission also expressed well wishes to two Commissioners who completed their service as well as four students who served during the 2023-2024 school year.

2024 Challenges

While the Commission did not experience challenges with its duties, the Commissioners proactively requested and underwent updated training on Title 12 of the Naperville Municipal Code. Taking these proactive measures assisted the Commission in deciding matters consistent with the provisions of the Municipal Code.

2025 Upcoming Work

In 2025, the Commission will open its first meeting by welcoming two newly appointed Commissioners. The Commission will also welcome two student representatives who have been appointed since its last meeting. The students will serve until the close of the 2024-25 school year. The Commission will continue its work of receiving, investigating, and processing complaints alleging violations of Title 12 of the Naperville Municipal Code.

Liquor Commission

Board Details

The City of Naperville's Liquor and Tobacco Control Commissioner Mayor Scott Wehrli is charged with the administration of the State of Illinois' Liquor Control Act, the City of Naperville's Liquor Code and the rules and regulations of the Liquor Commission. At the direction of the Liquor Commissioner, the Liquor Commission reviews applications and makes recommendations for licenses, conducts disciplinary hearings and submits findings and recommendations to the Liquor Commissioner. The commission also sends recommendations on liquor policy and procedure changes to the City Council. No member of the commission, or their spouse, parent, sibling or child, shall have any ownership interest in, or be employed by, any licensed establishment.

Liquor Commission 2024 Annual Report

2024 Accomplishments

- Onboarded a new Liquor Commission liaison.
- Onboarded 6 new Liquor Commissioners.
- Recommended approval of La Cantina's request for a Class C license and variance to the shopping center square footage requirements.
- Recommended approval of an annual licensing fee reduction for the Class S1 license.
- Recommended approval of Garfield's request for a variance to the shopping center limitation of one for a Class D license.
- Recommended approval of Block 59's request for pour limit increases for Class B licensees.
- Recommended approval of AJ's Liquorland's request for a variance to the shopping center square footage requirements of the Class D license to allow the purchase of Solo Liquor.
- Recommended approval of a text amendment to the Growler Permit to allow a licensee to sell fully sealed alcohol that is manufactured and packaged by the licensee.

2024 Accomplishments

- 1. The Prairie Nature Garden was completed by Naperville Park District and City work forces and contractors. The entire project was funded by the Naperville Riverwalk Foundation.
- 2. The public/private Riverwalk pathway connection to Aurora Avenue along the new row homes was completed.

Sister Cities Commission 2024 Annual Report

2024 Accomplishments

- The Sister Cities Commission worked with the Sister Cities Foundation to define and delineate the roles and responsibilities of each organization.
- The Commission designated specific members to lead efforts to reconnect and discuss initiatives with representatives of Cancun and Nitra.
- Commission members re-established the relationship with the Naperville Public Library promoting Sister Cities and Hispanic Heritage Month with a children's craft.
- Initial connections have been made with the Downtown Naperville Alliance, Naperville Development Partnership and the Chamber of Commerce regarding future opportunities.
- The Commission completed a refresher of FOIA and Open Meetings Act compliance.

2024 Challenges

- Efforts to clearly define roles and responsibilities between the Commission and Foundation were challenging given their closely linked missions.
- The Commission had four vacancies to fill in 2024 (two vacant seats and two expiring terms).
- Finding the appropriate people to connect with in Nitra and Cancun is challenging and will continue to take time and effort.

- Strengthen relationships with representatives of Cancun and Nitra.
- Further identify opportunities across trade, education, arts and culture with Nitra and Cancun.
- Leverage and partner with local organizations (Library, School Districts, Cultural Art groups, Naperville Development Partnership (NDP), Naperville Area Chamber of Commerce, Downtown Naperville Alliance (DNA), churches, businesses) to create these opportunities.
- Work with the Sister Cities Foundation to identify funding for these initiatives.
- Identify contacts in Pátzcuaro and evaluate partnership opportunities.

2024 Accomplishments

- Onboarded six new board members.
- Recommended approval of restricting parking in residential districts for vehicles over 6 tons.
- Recommended approval of establishing a new traffic schedule and modifying parking restrictions on streets adjacent to numerous schools.
- Recommended approval of modifying parking restrictions in the Park Addition neighborhood.
- Recommended approval of amending the existing valet parking ordinance and denial of a valet parking transfer zone request on Jefferson Avenue.
- Received staff's evaluation of traffic calming measures on Gartner Road between Washington Street and Charles Avenue.

2024 Challenges
